



**PUBLIC PATH DIVERSION AND
DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER**

**HIGHWAYS ACT 1980
WILDLIFE AND COUNTRYSIDE ACT 1981**

**SHROPSHIRE COUNCIL THE SHROPSHIRE COUNCIL (FOOTPATH 39 PARISH
OF HIGHLEY) PUBLIC PATH DIVERSION ORDER 2026.**

This Order is made by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that in the interests of the landowner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

This Order is also made under section 53A (2) of the Wildlife Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

BY THIS ORDER:

1. The public right of way over the land situated between Redstone Grove and Silverdale Terrace and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date of confirmation of this Order and thereupon the Shropshire definitive map shall be modified by deleting from it that public right of way.

2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely:

Where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

3. There shall on the date of confirmation of this Order be a public footpath over the land situated between Redstone Grove and Silverdale Terrace described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order and thereupon the Shropshire definitive map shall be modified by adding that path to it.

3A. The Shropshire definitive statement shall be modified as described in Part 4 of the Schedule to this order.

4. The diversion of the footpath shall only have effect on the date on which Shropshire Council certifies that any works required to bring the footpath into a fit condition have been carried out.

5. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART I

Description of site of existing path or way

The full width of that part of the Footpath 39 from Point C on the Order Map at grid reference: SO 7378 8355) running through a pasture field in a general south easterly direction where it joins with Footpath 38A at Point B on the Order map at grid reference SO 7398 8348). A total distance of approximately 215 metres.

PART 2

Description of site of new path or way

A footpath to be created running from a pedestrian gate at Point A on the Order Map at grid reference SO 7380 8358, in a general ESE direction for approximately 205 metres on a natural surface to Point B on the Order map at grid Reference SO 7398 8348). From here the footpath will continue for approximately 99 metres in a general south westerly direction following the field edge on a natural surface to point D on the Order map at grid reference SO 7392 8341. A total approximate distance of 305 metres with a width of 2metres throughout.

PART 3

Limitations and conditions

Pedestrian gate at grid reference SO 7380 8358 to BS 5709

PART 4

Modification of Definitive Statement

A footpath to be created running from a pedestrian gate at Point A on the Order Map at grid reference SO 7380 8358, in a general ESE direction for approximately 205 metres on a natural surface to Point B on the Order map at grid Reference SO 7398 8348). From here the footpath will continue for approximately 99 metres in a general

south westerly direction following the field edge on a natural surface to point D on the Order map at grid reference SO 7392 8341. A total approximate distance of 305 metres with a width of 2metres throughout.




